

NOTICE OF SPECIAL ELECTION

GREENWOOD LAKE JOINT FIRE DISTRICT, IN THE TOWN OF WARWICK AND THE
VILLAGE OF GREENWOOD LAKE
ORANGE COUNTY, NEW YORK

FEBRUARY 28, 2017

NOTICE IS HEREBY GIVEN that a Special Election of the qualified voters of the Greenwood Lake Fire District (hereafter called the "Fire District") in the Town of Warwick and the Village of Greenwood Lake, Orange County, New York, will be held at the Greenwood Lake Firehouse located at 51 Waterstone Road, Greenwood Lake, New York on Tuesday, February 28, 2017. The polls shall open at 6:00 o'clock P.M. (Prevailing Time) and shall remain open until 9:00 o'clock P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes.

NOTICE IS HEREBY FURTHER GIVEN that pursuant to the resolution adopted by the Board of Fire Commissioners of the Fire District on January 12, 2017, the following Proposition will be submitted to the qualified voters of the Fire District for their approval or disapproval:

PROPOSITION

SHALL the bond resolution of Greenwood Lake Joint Fire District, in the Town of Warwick and the Village of Greenwood Lake, Orange County, New York, entitled: "BOND RESOLUTION OF GREENWOOD LAKE JOINT FIRE DISTRICT, IN THE TOWN OF WARWICK AND THE VILLAGE OF GREENWOOD LAKE, ORANGE COUNTY, NEW YORK (THE "FIRE DISTRICT")", ADOPTED JANUARY 12, 2017, AUTHORIZING THE CONSTRUCTION OF A NEW FIREHOUSE ON LAND OWNED BY THE FIRE DISTRICT LOCATED ON MOUNTAIN LAKES ROAD IN THE VILLAGE OF GREENWOOD LAKE, NEW YORK, INCLUDING GRADING OR IMPROVEMENT OF THE SITE AND PURCHASE OF THE ORIGINAL FURNISHINGS, EQUIPMENT, MACHINERY AND/OR APPARATUS REQUIRED FOR THE PURPOSES FOR WHICH SAID FIREHOUSE IS TO BE USED ("PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF, INCLUDING PRELIMINARY COSTS AND COSTS

INCIDENTAL THERETO, IS \$5,850,000; APPROPRIATING \$5,490,000 FOR SAID PURPOSE, INCLUDING THE APPROPRIATION OF \$140,000 FROM THE "REAL PROPERTY ACQUISITION AND IMPROVEMENT CAPITAL RESERVE FUND", THE EXPENDITURE OF WHICH IS HEREBY APPROVED AND IS IN ADDITION TO THE \$360,000 HERETOFORE APPROPRIATED FROM SAID RESERVE FOR THE PROJECT; AUTHORIZING THE ISSUANCE OF BONDS IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$5,350,000 TO FINANCE A PORTION OF THE APPROPRIATION HEREIN AUTHORIZED; STATING THAT THE PLANNING BOARD OF THE VILLAGE OF GREENWOOD LAKE, ACTING AS LEAD AGENCY PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT, HAS DETERMINED THAT THE PROJECT IS AN UNLISTED ACTION AND A NEGATIVE DECLARATION HAS BEEN ISSUED AND FILED; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF THE NEW FIREHOUSE IS THIRTY (30) YEARS, AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE," BE APPROVED?

All residents of the Fire District who were duly registered to vote with the Orange County Board of Elections on or before February 6, 2017, shall be eligible to vote at said Special Election.
